
Sub: Relaxation in retention of Railway quarter by the  
compassionate appointees in case of missing Railway  
servants.  
Ref: Railway Board's letter No. E(G) 2001 QRI-17 Dated 17-07-  
2002.

The issue of grant of relaxation in quarter retention to the spouse/wards of missing Railway employees beyond the existing retention period of maximum two (01+01) years granted under Board's above referred letter has been under consideration of Board for quite some time.

2. It has been decided that a relaxation of six months in retention of Railway quarter in case of compassionate appointment to the wards/spouse of the missing Railway employees where employee is missing and compassionate appointment begins after 02 years from the date of missing/lodge of F.I.R. may be allowed thus making the normal permissible period as two years and six months subject to the conditions laid down in the original letter dated 17-07-2002. The six months additional extension, so granted, is further extendable by another six months, only with the approval of the General Manager of the concerned Railway, in cases where finalization of compassionate appointment gets delayed thereby making the maximum period of retention on normal rent as three (1+1+1/2+1/2) years.

3. This issues with the concurrence of Finance Directorate of the Ministry of Railways.

विषय : लापता रेल सेवकों के मामले में अनुकंपा के आधार पर नियुक्त कर्मचारियों द्वारा रेलवे क्वार्टर अपने पास रखने के संबंध में छूट प्रदान करना।

संदर्भ : रेलवे बोर्ड का दिनांक 17.07.2002 का पत्र सं.ई(जी) 2001 क्यूआर-17।

बोर्ड के संदर्भाधीन पत्र के अंतर्गत लापता रेलवे कर्मचारियों के स्थायित्व/अभिलेखों को क्वार्टर अपने पास रखने के लिए प्रदान की गई अधिकतम दो (01+01) वर्ष की संयुक्त अवधि के बाद क्वार्टर अपने पास रखने के संबंध में छूट प्रदान करने का मुद्दा कुछ समय से बोर्ड के विचाराधीन रहा है।

2. यह विनिश्चय किया गया है कि लापता रेल कर्मचारियों के अभिलेख/स्थायित्व की अनुकंपा के आधार पर नियुक्ति के ऐसे मामलों में जहां अनुकंपा के आधार पर नियुक्ति कर्मचारी के लापता होने/एफआईआर दायर करने की तारीख से 2 वर्ष के बाद की जाती है, रेलवे क्वार्टर अपने पास रखने के संबंध में दिनांक 17.07.2002 के मूल पत्र में निर्धारित शर्त के अन्वयधीन छूट महीने की छूट दी जाए। इस प्रकार, सामान्य अनुमोद्य अधि 2 वर्ष और छह महीने बनती है। इस प्रकार प्रदान की गई छह महीने की अतिरिक्त अवधि को संबंधित रेलवे के महाप्रबंधक के अनुमोद्य से उस स्थिति में छह माह के लिए और बढ़ाया जा सकता है, जब अनुकंपा के आधार पर नियुक्ति प्रदान करने में विलम्ब हो और ऐसी स्थिति में सामान्य किराए पर क्वार्टर रखने की अधिकतम अवधि तीन (1+1+1/2+1/2) वर्ष होगी।

3. इसे रेल मंत्रालय के वित्त निदेशालय की सहमति से जारी किया जा रहा है।

Sub: Permission for retention of Railway accommodation  
in favour of the families of the missing Railway

Ref: Railway Board's letter No. E(G)96 QR1-36 dated

The matter regarding grant of permission for retention of Railway accommodation in favour of the families of the missing Railway employees has been under consideration as per Agenda Item No. 25/2001 in PNM (JCM-DC). The Matter has been considered and in supersession of Board's letter No. E(G)96 QR1-36 dated 29-1-97 it has now been decided that the family of missing Railway employee may be permitted retention of Railway quarters for a period of one year on payment of normal rent from the date of lodging of FIR (the period from the date from which the employee is missing till the date of filing FIR would automatically get regularised) with the police by the family of missing Railway employee. On the certification of the police authorities that the missing employee is not traceable and the whereabouts of the person could not be known, the family of the missing Railway employee may be permitted further retention of Railway quarter for a period of one year on payment of normal rent.

These instructions will come into force from the date of issue.

This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
