

Ad-hoc promotions in Construction and other Projects are governed by the instructions referred to above. Spirit of these instructions is to discourage ad-hoc promotions in such projects with an exception that in the exigencies only one ad-hoc promotion may be granted with the approval of the cadre controlling authority.

2. In the wake of the Hon'ble Apex Court's Judgment dated 27.08.2013 passed in Civil Appeal No.7292/2013, arising out of SLP(C) No.14007/2012, where a Railway employee holding an ex-cadre post is repatriated back to his parent cadre, it is advised that ad-hoc promotions granted against the ex-cadre post do not entitle an employee for protection of pay on repatriation to the cadre.

3. This issues with the concurrence of Finance Directorate.
