



**Subject : Payment of Productivity Linked Bonus to all eligible non-gazetted
Railway employees for the financial year 2013-2014.**

Attention is drawn to the Board's letter of even number dt. 26.09.2014 whereby the President was pleased to sanction provisionally, subject to the approval of competent authority, Productivity Linked Bonus (PLB) equivalent to **78 (Seventy Eight)** days wages without any ceiling on wages for eligibility for the financial year 2013-14 to all eligible non-gazetted Railway employees (excluding all RPF/RPSF personnel).


2. The necessary approval has been obtained from the Cabinet and therefore the provisional sanction for the payment of PLB as mentioned in the first paragraph herein above may be treated as regular.


