<u>Sub</u>: Minimum educational qualification for open market recruitment to various posts on the Railways.

The issue of enhancement of minimum qualification from Matriculation to 12th (+2 standard) to various posts on the railways which presently have minimum entry qualification of Matriculation in Pay Band-1 of ₹5200-20200 having Grade Pay of ₹1900, ₹2000 and ₹2400 has been under consideration of this Ministry.

After detailed deliberations it has now been decided by the Board that henceforth following categories in Non-Technical Popular Categories (NTPC) will have the revised qualification as shown in the table below:-
