- 2. The rate of this allowance as indicated w.e.f. 01.09.2008 will be increased by 25% whenever the Dearness Allowance payable on the revised pay scales goes up by 50%. Accordingly, the rates w.e.f. 01.01.2011 & 01.01.2014 are also illustrated above.
- 3. These orders would take effect from 01.09.2008.
- 4. All other terms and conditions governing grant of Coal Pilot Allowance will remain unchanged.
