Please connect new Para No. 4.1(m) Notes, added vide Board's letter dt. 18.04.2012 referred to above, according to which in team game sportspersons who actually played the sport in field, shall only be eligible for recruitment against sports quota.

The matter of considering the cases of sportspersons who are found eligible for recruitment against sports quota in team games, but have not submitted the certificate for actual participation in field for their recognized sports achievements alongwith his/her application, has been considered in Board's office. In this connection it has been decided that the applicants who have not submitted the certificates for his/her sports achievement in team game as per Railway Board's letter 2012/E(Sports)/4(1)/1/Policy Clarification dated 15.06.2012 (RBE No. 71/2012), may be asked to submit the same before the day of trial. In the case of failure of submission of such certificate, candidate should not be allowed to appear in the field trial.
