Sub: Extension of deputation period of Railway employees with PSUs/Autonomous bodies beyond three/four years – adherence of existing instructions/guidelines thereof.

As you are aware the DOP&T and the DPE's guidelines on the subject have continued to be circulated to the Zonal Railways by the Ministry of Railways from time to time vide their letters:

- (i) No. 85/E(O)II/4/26 dated 26.07.1988
- (ii) No. E(NG)I/89/DP/24 dated 01.11.1089
- (iii) No. F(E)II/2007/DE/1 dated 24.07.2007
- (iv) No. F(E)II/2008/DE/1/1 dated 04.04.2008
- (v) No. 2010/F(E)II/1/(1)/1 dated 28.07.2010 &
- (vi) No. 2010/F(E)II/1(1)/1 dated 13.05.2011

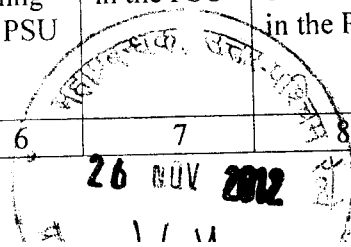
In addition, the Railways were also requested to forward the statement of railway employees on deputation with PSUs on quarterly basis to the Railway Board vide its letter No. E(NG)I-2010/DP/23 dated 24.09.2010.

However, it has been observed that these guidelines/instructions are not being followed by the Railways in their letter & spirit.

Recently, while considering a proposal for extension of the deputation of certain NG staff the DOP&T has desired to have the complete and updated information of all Railway personnel sent on deputation/foreign service and their present status with regard to regularization/extension/absorption etc in the PSUs under the Ministry of Railways to ensure effective monitoring and ensuring that no officer is allowed to overstay beyond the approved tenure and also the borrowing authorities my need to be informed that relaxation in the provision cannot be taken for granted and any overstay may entail liabilities under their O.M.No. 6/8/2009 Estt(PayII) dated 1st March 2011.

Accordingly, to keep a watch and also to apprised the DOP&T about the status of Railway employees on deputation with various PSUs/Autonomous bodies, you are requested to forward the information in the following proforma within 15 days of the receipt of this letter :



To enable this office to monitor the extension of staff on deputation with the PSUs/Autonomous bodies, in an effective manner and as desired by the DOP&T, the above information may also continue to be sent to the Board on quarterly basis i.e. by 15th of March, June, September and December every year. Railway may also consider developing a separate monitoring system at its own level for the purpose.

Further, before relieving the staff on deputation with the PSUs/Autonomous bodies and also to avoid any objections either from DOP&T OR Audit, Railway may ensure that they have been allowed to draw the Grade/Grade Pay in terms of DOP&T and DPE's guidelines.

This may be treated as URGENT.
