Sub. :- Formation of panel of Assistant Sports Officers (Group-B Gazetted posts) – Recommendations.

It has been decided to prepare a fresh panel for filling up the eight vacancies in the ex-cadre tenure posts (Group-B Gazetted) of Assistant Sports Officers in scale Rs.9,300-34,800+4,800 (Grade Pay) on different Railways/Units on deputation basis. In accordance with the recruitment rules framed for these posts, the conditions of eligibility for Railway employees shall be:-

- (a) Holding analogous posts on regular basis with at least two years regular service in posts having pre-revised scale Rs.6,500-10,500 (5th Central Pay Commission) or equivalent pay scale in existing pay scales;
OR
At least four years regular service in posts having pre-revised scale Rs.5,500-9,000 (5th Central Pay Commission) or equivalent pay scale in existing pay scales;
OR
At least eight years regular service in posts having pre-revised scale Rs.5,000-8,000 (5th Central Pay Commission) or equivalent pay scale in existing pay scales;
- (b) With outstanding record in sports activities, preferably having been International and National winners;
OR
With outstanding contribution as a sports organizer by holding office at least for 5 years of:
(i) Secretary/President/Joint Secretary of the National Sports Federations of which RSPB is an affiliate;
(ii) Secretary or President of the State Unit of such Sports Federation.

2. The Railways/Units may recommend the names of Railway employees fulfilling the above mentioned eligibility criteria, for further consideration in Board's office.

3. An undertaking may also be obtained from each candidate stating that he/she will not refuse the promotion and posting orders in case of his/her final selection. The candidates should also make themselves available for appearing in the selection process as and when conducted by the Railway Board.


