- (a) Diploma in Public Health & Sanitation Technology awarded by Institute of Public Health & Hygiene, Mahipalpur, New Delhi; and
- (b) Diploma in Health & Sanitary Inspection awarded by Vinayaka Mission University, Salem.

The issue has been under examination of this Ministry and it has now been decided that aforesaid Diploma cannot be accepted in lieu of the prescribed qualification for direct recruitment from open market to the post of Health & Malaria Inspector, Grade-III in Pay Band of ₹9300-34800 (Grade Pay: ₹4200).
