Sub. :- Recruitment of sportspersons against sports quota in team games.

Ref. :- Board's letter No. E(Sports)/2007/Policy/4(Clarifications) dt. 18.04.2012 (RBE No. 52/2012).

Vide Para 4.1(m) of Board's above cited letter actual participation of sportspersons in the field, in team games is mandatory towards eligibility for recruitment against sports quota on Railways.

2. National Sports Federations, Indian Olympic Association and Association of Indian Universities have since been advised by RSPB on 18.05.2012 (copy of letter enclosed) for issue of such certificates to sportspersons for team/group/relay events, for the said purpose.

3. In this connection, it is again clarified that submission of certificate by the candidate for actual participation in the field of play, in the event under consideration for recruitment, is mandatory.

**Sub.:- Certificates issued to sports persons for their sports achievements.**

As per extant policy, for recruitment of a sportsperson on Indian Railways against sports quota in team games, only the sportspersons who have actually played in field, are eligible. Therefore, a sportsperson who represents as member of a team in any recognized sports event/championship but has actually not played in the field, are not to be considered for recruitment against sports quota.

In view of above, it is requested that while issuing the merit/participation certificates to sportspersons for team/group/relay events (events other than Singles/individual event), also state or issue a certificate for their actual participation in the field during the championship, along with the details of matches and results, to make them eligible for consideration for recruitment on Indian Railways against sports quota, as per rules.
