Sub: Scheme for disbursement of pension to Railway pensioners through  
Public Sector Banks - Amendment

Under the scheme for disbursement of pension to Railway Pensioners through Public Sector Banks, Railway Board has designated FA&CAOs of Zonal Railways to settle pension debits received from the banks located within their regional jurisdiction. Consequent upon formation of the new state of Telangana, it is decided that FA&CAO/South Central Railway/Secunderabad shall be the designated FA&CAO for receiving/settling pension debit claims of banks located in Telangana. Further, all PSBs presently authorized to disburse pension to Railway pensioners in the state of Andhra Pradesh shall continue to be authorized for Telangana also.

In addition, the branches of the following Banks are authorized to make Railway pension payments in the states mentioned against their names. A copy of the representations received from the Banks is enclosed.

S.No	Name of the bank	Name of the States
1.	Bank of Baroda	Karnataka, Kerala, Andhra Pradesh, Telangana, Odisha, Jharkhand, Himachal Pradesh and J&K
2.	Punjab National Bank	Maharashtra, Gujarat, West Bengal, Orissa, Tamil Nadu, Kerala, Andhra Pradesh and Karnataka
3.	IDBI Bank	Maharashtra, Uttar Pradesh, Tamil Nadu, Gujarat, Madhya Pradesh, West Bengal, Karnataka, Andhra Pradesh and Telangana
