

In pursuance of Government's decision on the recommendations of the Fifth Central Pay Commission, instructions regarding grant of Fixed Medical Allowance to Railway Pensioners/Family Pensioners were issued vide Board's letter No. PC-V/98/1/7/1/1 dated 21-4-99 and subsequently amended from time to time, the last being letter No. PC-V/2010/A/Med./1 dated 29-06-2010. Some references have been received in Board's office stating that no endorsement regarding ineligibility for OPD facility is being made in the RELHS card of those Pensioners who are availing FMA and that such a situation is prone to misuse of the facility. With a view to prevent any possibility of misuse of OPD facility by a Pensioner/Family Pensioner, it is advised that on the RELHS card of Pensioners/Family Pensioners following endorsement may please be made in clear terms :

"Whether eligible for OPD facility—Yes/No."

2. All the concerned may please be instructed to ensure the aforementioned endorsement in the RELHS card of Railway Pensioners/Family Pensioners.
