It is therefore, desired that para 7, 8 & 20 of the bye-laws of All India OBC Railway Employees Federation are binding on the Zonal OBC Association and the same should be followed scrupulously.

### 7) AFFILIATION AND MEMBERSHIP

Any bonafide Association of Other Backward Classes railway employees engaged or employed in Indian Railways, or in an Independent Railway Undertaking or in any other establishment office or project under the Railway Board and registered under the Society Act is eligible for affiliation by the working committee subject to the sanction of the Central Executive Committee provided that.

- a) It agrees to abide by the rules, regulations and discipline of the Federation and not to act in any manner prejudicial to its collective interests.
- b) It submits to the Federation a statement of accounts and membership properly audited and certified as per the provisions of the Society Act 1860, for every official year within three months after the end of the year.
- c) It has a membership determined after proper scrutiny of not less than 15% of the total Other Backward Classes railway employees employed therein.
- d) It agrees to pay an affiliation fee at the rate of Re.Two per member per annum.
- e) It agrees to pay any further levy or levies that may be decided upon by the Central Executive Committee.
- f) Zonal Associations / Production Units Seeking Affiliation with the Federation shall apply in the prescribed form No.7(1) Viz page 16:16

DISAFFILIATION (LOSS OF MEMBERSHIP) or ch

Any affiliated Association shall lose its membership of the Federation if it is in default of dues for more than six months after the end of the Financial Year.

# 9) COMPOSITION OF THE A.I.O.B.C FEDERATION

The Federation shall consist of:

A) THE GENERAL BODY -

The General Body of delegates from all the affiliated Association, whose office bearers list is circulated by the administration. The General Body is the supremethody of the Federation and shall consist of elected office bearers of the

is undertaken for the purpose of securing or protecting any rights of the Federation or its affiliated Associations.

- d) The conduct of disputes on behalf of the Federation or its affiliated Associations.
- e) The upkeep of a periodical published mainly for the purpose of discussing questions affecting O.B.C railway employees as such,
- f) Any other expenses provided in the Society Act.

## 19) CUSTODY OF FUNDS

- a) ... The Central Executive Committee shall be responsible for the safe custody of the funds of the Federation, and shall decide from time to time the bank or banks wherein the funds of the Federation shall be deposited.
- b) The money deposited in the bank in the name of the Federation, shall be withdrawn only by cheque jointly signed by any two of the three (ie) President, General Secretary and Treasurer/Finance Secretary.
- c) The General Secretary shall be allowed an imprest every month not exceeding Rs 500/-
- d) The Finance Secretary/Treasurer shall maintain the accounts of the Federation.

The General Secretary shall maintain a list of membership of the Federation for Expression year from 1st January to 31st December.

The accounts and list of membership shall be open for inspection during the office with hours of the Federation. A notice of not less than seven days shall be given in writing any member or officer of the Federation or by any person deputed for this purpose by the Railway Administration.

g) rar of the South of the Annual Accounts and of the Annual Report of the Federation will be submitted to the Railway Board. (ie) EDE (RES).

## 20) DISCIPLINARY ACTION:

a) Any officer of the Federation or any affiliated Association may be suspended from membership of the Federation or expelled for disloyal conduct or for injuring the interests of the Federation in the following manner.

The Central Executive Committee may suspend or expel from membership any
officer or affiliated associations of the Federation or on its own motion, provided.

that the decision is taken by a three - fourth majority of the members of the Central Executive Committee, provided further that the officer or the Association concerned has been given an opportunity, according to the rules framed in this behalf by the Central Executive Committee, to answer the charges framed.

- In case of expulsion, an appeal shall be made to the central executive committee. ii)
- The Central Executive Committee may also by a resolution impose fines and penalties for default in the fulfillment of any obligation to the Federation.

#### 21) VACANCIES

Vacancies of office bearers of the Federation shall be filled in by election at the General Body Meeting of the A.I.O.B.C Federation.

#### TRADE UNION ACTIVITIES 22)

The Federation will not involve in trade union activities.

23) POLITICAL RESOLUTIONS

> Resolutions on political questions to be acopted sli o-third majority of the members present.

Amendments to the constitution can be made only by the General Body Meeting by a two-third majority. Amendments will be sent to the Registrar within 14 days and shall not be in force till this registration with the Registrar.

Any proposed amendments to the Constitution of the Federation must be notified to the delegates along with the notice convening the meeting of the General Body Meeting.

## SPECIAL POWERS OF CENTRAL EXECUTIVE COMMITTEE:

The Central Executive Committee may frame bye-laws and regulations not inconsistent with the Constitution for the purpose of carrying out the business of the Federation.
