Sub:- Revised pay limits for entitlement of Passes & PTOs on basis of pay drawn in Railway Services (Revised Pay) Rules, 2008.

Ref:- Your Railway's letter No.E(Pass)768/45Vol.VI dated 6.3.2013 and 19.7.2012.

The matter has been examined. Point wise clarifications sought by the Railway are as under:-

- (i) As per extant provisions of Railway Servants (Pass) Rules, 1986 (revised edition-1993), the class of PRCP and Widow Passes would be same as admissible to Railway employees at the time of their retirement. As for distinction of employees on the basis of groups, separate instructions exist for Gazetted and non-gazetted employees. Copies of Board's letter No.E(W)2008/PS5-1/38 dated 06-01-2011 and 03-02-2011 are enclosed in this regard.
- (ii) Employees working in G.P Rs.1800/- and above but below G.PRs.2800/- are being provided with one Second Class 'A' pass once in a year as a goodwill gesture. Their entitlement is however of Sleeper/Second Class. So after retirement they will be eligible for Sleeper/Second Class pass. As regards employees in G.P2800/-, their pass entitlement is Second Class 'A' pass and it will remain the same after retirement.
- (iii) Board's instruction dated 06-01-2011 are effective from the date of issue. The pass entitlement of the employees retired prior to issue of the said letter dated 06-01-2011 shall be regulated in terms of Board's letters No.2008/PS5-1/43 dated 15.01.2009 and E(W)97/PS5-1/62 dated 1.2.1999 (copies enclosed).



Sub: Regulation of entitlement of Privilege Passes pending issue of orders on the basis of the recommendations of the 6th Central Pay Commission.

A question has been raised as to bow the continement of Privilege Passes should be regulated in respect of persons whose pay may be fixed in the revised scales of pay, promulgated under the RS(RP) 2008, pending issue of revised pay limits.

- 2. It is hereby clarified that the 'Pay' in the pre-revised scale (Vth Central Pay Commission Scale) should continue to be the basis for gradation and related entitlement. In respect of the persons continuing in posts held prior to 01-01-2006 whose pay may be fixed in the revised Pay Bands/Scales, 'Pay' for purpose of passes will be the 'Pay' in the Vth Central Pay Commission Scale that would have been drawn but for fixation of pay in the revised Pay Bands/Scales. In the case of persons who are either appointed to different posts on or after C1-01-2006 or initially recruited on or after that date the 'notional' pay which they would have drawn in the pre-revised scales but for the introduction of the revised Pay Bands/Scales, should be taken into account.
