

10.01.1995 and No.2005-E(SCT)I/22/13 dated 11.07.2007.

It has been brought to the notice of Board that the para 1(xvi) of the bye-laws of the All India SC/ST Railway Employees Association are not being followed and the list of office bearers of Divisional Executive Committee (DEC) and Branch Executive Committee (BEC) are being granted direct approval by the CEC of AISC/STREA and forwarding the same to the concerned Railway administration for circulation. These are being done in case of elected office bearers as well as in the case of nominating list of Adhoc Committee, which is creating confusion and insecurity among the office bearers and members of the SC/ST Association.

It is therefore reiterated that Board's standing instructions issued vide Board's letter No.93-E(SCT)I/22/1 dated 16.06.1994 and 10.01.1995 and Board's letter No.2005-E(SCT)I/22/13 dated 11.07.2007 may be strictly followed and the list of an Executive body will be signed and submitted to the Railway administration for circulation by the President and Secretary of the "respective upper body". Further, Association should ensure that elections of the said Association should be conducted well in advance with prior notice of 21 days and should finish within 15 days from the expiry of its tenure. The formation of adhoc-Committee of the Association should generally be discouraged, and if created, it should not continue beyond the laid down limit (i.e. 4 months) from its formation in any case and by which they have to ensure fresh elections and place a regular democratically elected body otherwise the facilities being enjoyed by the Association will be withdrawn with immediate effect so as to remove the ill-practices, confusion and to bring transparency in the matter in the smooth functioning of the Association. It is also reiterated that the instructions contained in Board letter dated 11.07.2007 should be followed strictly.
