

2. The Ministry of Railways (Railway Board) has now decided to issue three 1<sup>st</sup> AC Card Passes by (i) upgrading the existing two 2<sup>nd</sup> AC Card Passes provided to the President/Working President and General Secretary for all India jurisdiction at Apex level and, (ii) 1<sup>st</sup> AC Card Pass to Vice President/CEC of All India OBC Railway Employees' Federation. And the existing Zonal Card Passes of Zonal President and Zonal Secretary with zonal jurisdiction may also be extended upto Delhi/New Delhi.

3. Necessary action may be taken accordingly.
