> Sub: Revised pay limits for entitlement of School Pass, School Card Pass and Residential Card Pass.

Consequent upon revision of Pay Scales on the basis of decision of the Government on the recommendations of 6th Central Pay Commission, the question of revision of existing entitlements to School Pass', School Card Pass' and Residential Card Pass' under the Rallway Servants (Pass) Rules, 1986 (Second Edition, 1993) has been under consideration of this Ministry.

- The matter has been examined and in exercise of the powers conferred by the proviso to Article 309 of the Constitution, the President is pleased to direct that the pay limits for entitlements to 'School Pass', 'School Card Pass' and 'Residential Card Pass' be revised as per Advance Correction Stip No. 69 attached.
- In all other respects, the existing provisions of the Railway Servants (Pass) Rules, 1986 (Second Edition, 1993), as amended from time to time shall continue to apply.

Thowever, the children of railway employee studying in Oak Grone School, Jharipani, who are not orginarily entitled to 1st Class Passes, may, as a special case, be issued 1st Class Passes from their hories to Dehradun at the beginning of school session and back to their homes at the conclusion of the school session. The above provision equally applies for their up and down journeys during authorised vacations. On these occasions, 1st Class Passes may also be issued to the escorts (school, teachers) for their up and down journeys;
