Railway Staff Benefit Fund

Advance Correction Slip No. 117

(1) Clause (1) of Rule 805 may be substituted by the following :

In addition to the credits to the Fund detailed in Rule 804, there shall be credited to the fund on the 1st April of each financial year an annual grant from the revenues of the Railway at a per capita rate of ₹ 500/- based on the sanctioned strength of nongazetted Railway employees, permanent and temporary, as on the 31st March, posts charged to capital being excluded. The Fund shall be credited provisionally on the 1st April each year with an amount equal to the contribution for the previous year, the necessary adjustment being made as soon as the correct amount of the contribution has been determined. Based on the overall per capita contribution of ₹20.00 for sports activities, sports allotments shall continue to be made by the Ministry of Railways in consultation with the Railway Sports Promotion Board, to the Zonal Railways/Production Units.

Allotment of $\overline{13.50}$ for scouting activities will also be made by the Ministry of Railways. $\overline{18}$ /- per capita allotted for "Immediate relief in times of crisis arising out of natural calamities" will be made from the "SBF Calamity Relief Fund" at the level of the Ministry of Railways. Therefore, allotment for $\overline{151.50}$ will be authorised centrally by Ministry of Railways (Railway Board) from sanctioned Budget allotments.

Earlier Board's letter No.E(G)98 EC2-3 dated 3.8.98 was modified and circulated vide this office letter No.EP/261/0 Vol.VII dated 13.10.98. GM, vide letter dated 13.10.98 had delegated powers for creation of NG post required for operation and maintenance of new assets to DRMs. These creations were to be done with equivalent matching surrenders and for which purpose divisions were permitted to maintain Divisional Vacancy Bank with 25% money value of posts surrendered.

Now Railway Board's revised instructions issued vide letter No.E(MPP) 2003/1/88 dated 05.04.2006 (R.B.E.No.45/2006) is enclosed herewith for information and guidance. Necessary action may be taken accordingly, henceforth.

Sub: Creation of posts required for Maintenance and operation of new assets. Ref: Board's letter No.E(G)96 EC2-1 dtd 7.8.96(RBE No.65/96) ********

As per Railway Board's letter No.E(G)98 EC2-3 dated 3.8.98, the powers to create non-gazetted Group 'C' & 'D' posts required for maintenance and operation of new assets with matching surrender of posts of equivalent money value, was delegated to Divisional Railway Managers. They were permitted to operate a Vacancy Bank in their Division by crediting up to a maximum of 50% of the money value of the posts surrendered by them and the balance to be credited to the HQ Vacancy Bank.

The issue of allowing creation of posts in Safety and operational categories has been under consideration of Board. It has been decided that the DRMs may be allowed to create the above posts on 1:1 basis, i.e. by surrendering 1 post in a particular grade, a fresh post can simultaneously be created in the same/ lower grade, with the approval of General Manager. The revised stipulation as above is however, subject to surrender of posts as advised in this office letter No.E(MPP) 2005/1/54/Vol.II dated 27.2.06 followed by ED(Trg. & MPP) letter dated 8.3.06.
