

Metal Passes in case of loss.


In supersession of Board's letter No.2009/G/127/4/Mint/Pt.II dt.10.02.2009 issued earlier revising the rate of recovery of replacement cost of the metal passes, it has been decided that the rates of recovery in case of loss of Gold/Silver/All India Bronze Metal Passes stand further revised with immediate effect as per the following:

Gold : Rs.10,950/-

Silver : Rs. 3,028/-

Bronze : Rs. 2,557/-

It is, therefore, advised that recovery of replacement cost of one Gold/Silver/Bronze Metal pass from the Officers who report loss of their metal passes, may please be made at the above rates and the amount so recovered be credited to Railway Board under Head : 64-B/Misc./Railway Receipts.
